Mål

After completion of the course students shall be able to:

- Account for the various tools and methods that are used in conflict resolution;
- Discuss the strengths and weaknesses of various traditional as well as alternative conflict resolution tools;
- Show theoretically as well as applied how crisis management and long-term peace building has been combined in conflict resolution intervention attempts.

- present how perspectives of and on gender relate to conflict resolution.

Innehåll

International Conflict Resolution is an interdisciplinary subject whose central questions touch upon humanistic, social scientific, historical as well as contemporary problems. The course objectives are to give basic orientation in methods and practises that are used in the field of conflict resolution and peace building. Emphasis is placed on analysing peacebuilding practiced by international actors and that have undergone some substantial evolutions since the end of the Cold War. The UN 'Agenda for Peace' in 1992 created a distinct category of practices within peace operations in war torn societies, but has also generated criticism.

Hence, the course provides the student with basic education in limits/potentials of the methods used in prevention, management, and resolution of conflicts, including post-conflict interventions. What lessons have been learned so far and how can we evaluate the various practises of conflict resolution methods? The course can serve as a complementary in-depth topic for students that have studied International Relations, Political Science, Economics and other social science subjects. The course also gives an orientation of the existing literature and trains the students to independently make use of it.

In this module, a presentation of methods within the field of conflict resolution will be made. Different negotiation strategies that are used by global agencies will be offered. These are different mediation/negotiation methods such as conventional diplomacy, Track II negotiations, and different problem-solving methods. Also, various grassroots, and civil society strategies that have been used, such as non-violent actions, mobilizing in peace movements etc, will be discussed. Furthermore, methods that explain how crisis management and long-term peace building can be combined will be critically elaborated and conferred. The student will practically make exercises on how such strategies can be applied.
