## **Entry requirements**

Admission to the course requires the student to have completed EKG101 Economic Geography: Regional Economic Development and Global Competitiveness, 7.5 credits, EKG102 Economic Geography: International Trade and Production, 7.5 credits, EKG103 Economic Geography: Economic Geography of the Nordic Countries, 7.5 credits and EKG104 Economic Geography - A Time Perspective, 7.5 credits or EGG101 Economic Geography, Introductory Level: Globalization of Business and Regional Development, 30 credits, or equivalent.

## Learning outcomes

On successful completion of the course the student will be able to:

1. apply and critically process previously acquired knowledge in economic geography

- 2. acquire complementary knowledge in a limited field in economic geography
- 3. independently carry out a smaller scientific study in economic geography

#### **Course content**

In this course, an independent thesis work is carried out on a freely chosen problem area in economic geography. The course involves practical applications of economic geographical topics. Theoretical perspectives and basic methods in scientific research and writing, e.g. source criticism and referencing systems, are introduced.

## Form of teaching

Lectures and seminars. The course seminars are compulsory.

Language of instruction: Swedish Teaching in English may occur.

## **Assessment**

The learning objectives are examined through the completion of an individual thesis work and participation in the compulsory seminar, where both the own thesis is presented and the other theses are presented and reviewed. A thesis opposition takes place between students. Students who submit their thesis for a non-regular examination to which no other thesis has been submitted, perform a written opposition on a previously submitted thesis. A thesis that does not meet the requirements for a passing grade (A-E) can either qualify for a re-submission in order to meet the minimum requirements or be deemed of such quality that the writing of an entirely new thesis is necessary. A revised thesis must be submitted for re-assessment within two months of the end of the course. The maximum grade awarded under such circumstances is Sufficient (E). Should the resubmitted thesis still not meet the minimum requirements, the student will be assigned a Fail (F). A revised thesis should not be presented on a seminar again.

If the student has been granted special educational support from the University of Gothenburg because of a disability, the examiner has the right to offer the student an adapted test.

If a student, who has failed the same examined element on two occasions, wishes to change examiner before the next examination session, such a request is to be submitted to the department in writing and granted unless there are special reasons to the contrary (Chapter 6, Section 22 of Higher Education Ordinance).

In the event that a course has ceased or undergone major changes, students are to be guaranteed at least three examination sessions (including the ordinary examination session) over a period of at least one year, though at most two years after the course has ceased/been changed.

#### **Grades**

The grading scale comprises: Excellent (A), Very good (B), Good (C), Satisfactory (D), Sufficient (E) and Fail (F).

To pass the course, a student must receive a passing grade on all intended learning outcomes. This means that a passing grade on the individual thesis work (A-E) is required. The compulsory elements of the course must also be completed. The course grade (A-F) is based on the individual thesis work.

### **Grade (Definition) Characteristic:**

A (Excellent) A distinguished result that is excellent with regard to theoretical depth, practical relevance, analytical ability and independent thought.

B (Very good) A very good result with regard to theoretical depth, practical relevance, analytical ability and independent thought.

C (Good) The result is of a good standard with regard to theoretical depth, practical relevance, analytical ability and independent thought and lives up to expectations.

D (Satisfactory) The result is of a satisfactory standard with regard to theoretical depth, practical relevance, analytical ability and independent thought.

E (Sufficient) The result satisfies the minimum requirements with regard to theoretical depth, practical relevance, analytical ability and independent thought, but not more.

F (Fail) The result does not meet the minimum requirements with regard to theoretical depth, practical relevance, analytical ability and independent thought.

Some occasional examination elements of the course may have the grading scale UG (Fail/Pass).

### **Course evaluation**

Course evaluation is anonymous and is issued either via the learning platform or via a written questionnaire at the last timetabled lesson or at the examination.

The results of and possible changes to the course will be shared with students who are starting the course.
