Position in the educational system

Entry requirements

General entrance requirements for university studies and the Swedish upper secondary courses English 6, Mathematics 3b/3c, Civics 1b/1a1+1a2 or equivalent.

Learning outcomes

On successful completion of the course the student will be able to:

- 1. Demonstrate basic knowledge of commercial law and related functional subjects.
- 2. Demonstrate basic knowledge of the social and legal policy role of commercial law

- in the surrounding society.
- 3. Demonstrate basic ability to reason about how different actors should relate to and act in various contexts considering commercial law.
- 4. Demonstrate the ability to develop solutions to legal problems.
- 5. Demonstrate basic skills in legal academic writing.
- 6. Demonstrate the ability for independent and critical reflection.

Course content

The course EKR112 Commercial Law builds on the knowledge that was introduced during the course EKR111 Introduction to Commercial Law (3 credits). Covering a spectrum of subjects, the course includes national and international sales, payments, trade financing, principles of insurance law, and insolvency.

Form of teaching

The teaching is provided through lectures, exercises, group work, and seminars.

Language of instruction: English

Assessment

Learning outcomes are assessed in the following way:

- an individual oral presentation through group work at seminars (learning outcomes 1, 2, 3 and 4)
- an individual written exam (learning outcomes 1, 2, 3 and 4)
- an individual essay (all learning outcomes)

Grades

The grading scale comprises: Excellent (A), Very good (B), Good (C), Satisfactory (D), Sufficient (E) and Fail (F).

To obtain a passing course grade, a passing grade is required for each of the examination components: the individual oral presentation, the individual written exam, and the individual written essay. To determine the final grade, the points from the examination components are combined.

Course evaluation

Upon completion, the course will be evaluated in accordance with the rules for course evaluations established by the Bachelor's Programme in Business and Economics at the School of Business, Economics and Law. The results of the evaluation as well as any

changes to the course structure shall be communicated to both the students who completed the evaluation and the students who are enrolled in the subsequent round of the course.
