Field of education: Fine Arts 50% and Design 50%

Position in the educational system

The course is given as an elective course within the Master's Program in Conservation, and is formulated out of individual needs for complementary studies

The course can be part of the following programmes: 1) Master of Science in Conservation (A) (N2KVA), 2) Master of Science in Conservation (N2KUV), 3) Master of Science in Conservation (D) with major in Building Conservation (N2KVD), 4) Master of Science in Conservation of Cultural Property (C) (N2KVC) and 5) Master of Science in Conservation (B), with major in Integrated Conservation of Built Environments (N2KVB)

Main field of studies

A1N, Second cycle, has only first-cycle course/s as entry requirements

Entry requirements

To be eligible for the course a Bachelor's degree in Conservation, or equivalent, is required.

Learning outcomes

After completed course the students will be able to:

Knowledge and understanding

- Demonstrate increased knowledge in the chosen complementary area.

Competence and skills

- Independently plan and formulate an individual paper on the chosen complementary area with an independent reflection and discussion.

Judgement and approach

- Collect and evaluate information and knowledge, such as previous research and other texts within the subject area of conservation and the chosen complementary area.
- Reflect on the general and specific knowledges of relevance for the studied area.

Course content

In dialogue with the examiner or the appointed supervisor the student select, plan and carry out an individual study in a complementary area as part of the student's orientation within the subject area of conservation.

Form of teaching

The course could be given as literature course, project course or field study, or as a combination of these, decided in dialogue with the examiner.

Language of instruction: Swedish and English

Assessment

The course is examined through an individual assignment.

Instructions for the examination and at which day it is scheduled, are provided in the course guide.

If specific reasons so motivate, the examiner might approve a different form of examination than stated above.

To achieve the grade Pass on the course or in a specific examination, an assignment to complete the examination could be provided through assessment and decision by the examiner.

A student who has failed the examination twice has the right to change examiner, unless weighty argument against this can be adduced. The application shall be sent to the department and has to be in writing.

Grades

The grading scale comprises: Pass with Distinction (VG), Pass (G) and Fail (U).
The individual assignment and the course are graded as follows:

Individual assignment: Pass (G), Pass with distinction (VG), or Failed (U).

Grade Pass on the course: Grade Pass on the individual assignment

Pass with distinction on the course: Grad Pass with distinction on the individual assignment

Course evaluation

The evaluation is performed individually. Performed evaluations are filed by the study administrator.

Additional information

Course content, complementary area, form of teaching, reading list, and assessment, will be described in the course guide for the individual student.

Costs: Expenses may occur in connection with the course, these are paid for by the student.
