Position in the educational system

Course is an advanced course at second cycle level and can include in Degree of Master (120 credits) in social work Degree of Master (60 credits) in social work or Master of Science in Health Care Counselling. The course is also given as a freestanding course.

The course can be part of the following programmes: 1) Master's Programme in Social Work and Human Rights (S2SWH) and 2) Programme for Master of Social Science with a Major in Social Work (S2SOA)

Entry requirements

To be eligible for the course, a 210 credit Degree of Bachelor of Science in Social Work, a 180 credit Degree of Bachelor in social work, or a Bachelor Degree in another closely related field is required

Learning outcomes

On successful completion of the course the student will be able to:

Knowledge and understanding

- at the advanced level give an account of and discuss different theoretical perspectives on family treatment with relevance for social work
- account thoroughly for, analyse and assess psychosocial interventions with relevance for family work.
- show advanced knowledge of conversation and interview technique with individuals and families

Competence and skills

- independently analyse family related crisis, conflicts and violence on the basis of theories of interplay and network
- review and evaluate models for working with families within the scope of social work in relation to the concept evidence-based practice
- apply children's perspective on family treatment processes
- independently apply conversation's and interview techniques with individuals and families

Judgement and approach

- demonstrate the ability of reflexive and critical thinking in relation to the own professional role in the work with children, families and networks
- in an initiated way describe and discuss ethical dilemmas that follow from professional assessments and interventions with special consideration of a client perspective and power dimensions

Course content

The course covers theories and concepts that can be used to understand and analyse family work. Professional assessments and interventions are central in the course. Furthermore, there will be a focus on ethics and power dimensions in family work.

Form of teaching

The teaching consists of lectures and seminars (on campus and online).

Language of instruction: Swedish

Assessment

The course is assessed through:

1. compulsory seminars where the student submits an individual written task before the seminar. These are assessed with Pass (G) or Fail (U). In case of absence, supplementary qualification is required.
2. a compulsory individual project work (the family treatment project). The project work examination is assessed with Pass with distinction (VG), Pass (G) or Fail (U).
3. a compulsory examination seminar where the student presents their project work. In case of absence, supplementary qualification is required.

The student is given the possibility to participate in at least two re-examinations within one year from the start of course.

If a student who has failed the same examined component twice, wants to change examiner, they should submit a written request to the department responsible for the course. The request shall be granted unless there are special reasons to the contrary (Chapter 6, Section 22 of Higher Education Ordinance).

A student with a recommendation for special educational support from the University of Gothenburg may receive an adapted examination or alternative examination form provided that the examiner decides it is compatible with the course objectives and unreasonable resources are not required.

In the case where a course has been discontinued or has undergone major changes, the student should normally be guaranteed access to at least three examination sessions (including the regular examination session) during a period of at least one year, but at the most two years after the course has been discontinued/changed. The same applies for internships and on-the-job trainings, but with a restriction to only one additional examination session.

Grades

The grading scale comprises: Pass with Distinction (VG), Pass (G) and Fail (U).

For Pass, it is required that all aims above are satisfied. For Pass with distinction, a very good ability to connect theoretical analyses with practical consequences, an independent and good analytical ability and that the written project presentation satisfies high set academic requirements of structure, diction and presentation is furthermore required.

Course evaluation

Course evaluation takes place continuously during the course, through a dialogue with the students, at a compulsory workplace meeting as well as through a special evaluation protocol at the end of the course.
